

LCL combines shipments from multiple companies, sharing space and transportation costs.





IMPORTER REGISTRY

The Importer Registry is a registration controlled by the SAT (Mexican Tax Authority) that all individuals and entities must be registered with to import goods into the national territory. We have a General Importer Registry through which, with the help of our network of Registered Customs Agents, we import your goods through any customs point in the country, whether it be by land, sea, rail, or air.

Benefits:

Immediate importation of goods, even without registration on any of the registries.

Importation of goods for Mexican or foreign companies that do not wish to undergo the import registration process due to sporadic foreign purchases, avoiding constant fiscal procedures and updates.

Allows a greater focus on your business without complicating operational processes with import procedures.

For imports where payment to the foreign supplier has not yet been made, we can make the payment through our company to facilitate accounting and fiscal records
